WINDSOR LAKES HOMEOWNERS ASSOCIATION BOARD OF DIRECTORS RESOLUTION CONCERNING RECREATIONAL VEHICLE PARKING IN THE WINDSOR LODGE PARKING LOT

WHEREAS, the Declaration of Covenants, Conditions and Restrictions for Windsor Lakes Homeowners Association, Inc., is filed in the Real Property Records of Montgomery County, Texas, under Clerk's File No. 2003068161, along with any supplements thereto or amendments thereof (the "Declaration"); and

WHEREAS, Article VI, Section 1, and Section 11, of the Declaration authorizes the Association Board of Directors to promulgate rules and regulations applicable to all lots, units and common areas; and

WHEREAS, Article VI, Section 8, of the Declaration prohibits the parking or storage of a Recreational Vehicle on any portion of a Lot or Unit unless completely concealed from public view; and prohibits overnight parking on streets; and

WHEREAS, Article VI, Section 8, of the Declaration allows the Board of Directors to grant a temporary parking variance provision;

NOW THEREFORE BE IT RESOLVED that the following rules governing the parking of Recreational Vehicles in the Windsor Lodge parking lot are hereby adopted by the Windsor Lakes HOA Board of Directors:

Definition: the term "Recreational Vehicle" is used to define any self-contained motor coach, vehicle towed travel trailer, and vehicle towed trailer for other uses such as boats, marine craft, and U-Haul type moving trailers.

- No vehicle, except passenger vehicles and authorized maintenance vehicles, as defined in Article VI, Section 8 may be parked in the Windsor Lodge parking lot without being granted a temporary parking variance.
- Recreational Vehicles may only be parked for a maximum period of 24 hours, and only by prior permission from the Board through the Windsor Lodge Staff.
- Advance notice of at least 24 hours is required for permission to be granted.
- When parked, the Owner of the Recreational Vehicle must "register" with the Windsor Lodge staff before leaving the parking lot. The staff will record the resident's name, phone number, and time in. If the owner or driver of the vehicle is the guest of a Windsor Lakes resident, it is the Windsor Lakes resident who must provide their name and contact number, as well as the name of the guest.
- Recreational Vehicles will not be allowed to park in the Windsor Lodge parking lot during peak periods when there is a major function at Windsor Lodge.

- Recreational Vehicles may only be parked in the designated portion of the Windsor Lodge parking lot.
- Only one recreational vehicle will be allowed to be parked in the Windsor Lodge parking lot at any one time and will only be allowed with prior approval on a first come, first served basis.
- The Board of Directors may choose to modify the rules governing the parking of recreational vehicles in the Windsor Lodge parking lot at any time.
