

## WINDSOR LAKES HOMEOWNERS ASSOCIATION

## RESOLUTION

WHEREAS, Windsor Lakes ("WL") in The Woodlands is an age-restricted community operated in compliance with the Windsor Lakes Homeowners Association ("WLHOA") governing documents and all applicable local, state and federal laws and intended for use by residents 55 years of age or older; and

WHEREAS, The U.S. Department of Housing and Urban Development ("HUD") has promulgated regulations that pertain to communities such as WL that restrict occupancy for households and require that at least one "qualifying" occupant to be 55 years of age or older. In order for an age-restricted community to legally maintain its age restriction, at least 80% of the households in the community must be in compliance with the age restriction; and

WHEREAS, HUD regulations require that the WLHOA monitor age compliance of the community and maintain records of age compliance that are subject to review and audit; and

WHEREAS, The WLHOA Board of Directors is required to establish and oversee policies and procedures in accordance with the WLHOA governing documents to ensure that WL maintains its status as an age-restricted community under state and federal law; and

WHEREAS, the WLHOA governing documents prohibit any person under the age of 19 years to permanently reside within the community and limits such individuals' residency to no more than 60 total days in any calendar year.

NOW THEREFORE, the Windsor Lakes HOA Board of Directors hereby adopts this Resolution that will require any WL homeowner, or prospective buyer to request an exception to the WL age restriction requirement when the qualifying resident is under the age of 55 years; and
