WINDSOR LAKES HOMEOWNERS ASSOCIATION BOARD OF DIRECTORS RESOLUTION CONCERNING USE OF MOTORIZED VEHICLES IN COMMON AREAS

WHEREAS, the Declaration of Covenants, Conditions and Restrictions for Windsor Lakes Homeowners Association, Inc., is filed in the Real Property Records of Montgomery County, Texas, under Clerk's File No. 2003068161, along with any supplements thereto or amendments thereof (the "Declaration"); and

WHEREAS, Article VI, Section 1, and Section 11, of the Declaration authorizes the Association Board of Directors to promulgate rules and regulations applicable to all lots, units and common areas; and

NOW THEREFORE BE IT RESOLVED that the following rules regulating and restricting the use of motorized vehicles in the common areas and sidewalks in Windsor Lakes are hereby adopted by the Windsor Lakes HOA Board of Directors:

Definition: the term "Motorized Vehicle" is used to define golf carts, miscellaneous electric vehicles, small engine driven vehicles, and all-terrain vehicles and does NOT include electric wheelchairs or scooters for the disabled.

- Motorized vehicles are strictly prohibited from being driven on any Common Areas, including sidewalks, within Windsor Lakes other than on the private streets and Windsor Lodge parking lot.
- It is recommended, but not required, that all motorized vehicles operated on private streets in Windsor Lakes have operational front and rear driving lights, brake lights, and a rear view mirror.
- Drivers of motorized vehicles in Windsor Lakes must be at least 16 years of age.
- Drivers of motorized vehicles in Windsor Lakes must not operate the vehicles with more people inside or on the vehicle than recommended by the manufacturer's specifications.
- Authorized maintenance vehicles under contract with Windsor Lakes HOA, such as a landscaping company, and authorized public service vehicles performing work on the Common Areas and private streets, may access the Common Areas and streets to perform authorized work.
- Use of motorized vehicles is allowed by special variance granted by the Board of Directors in the perimeter common areas of Windsor Lakes for periodic inspections of the outer property boundaries.

- No provision in the preceding rules and regulations regarding motorized vehicles is intended to limit or restrict the use of electric wheelchairs or scooters designed for the use of persons with disabilities.
- The Board of Directors may choose to modify the rules governing the use of motorized vehicles in common areas at any time.
