WHEREAS, the Declaration of Covenants, Conditions and Restrictions for Windsor Lakes Homeowners Association, Inc., is filed in the Real Property Records of Montgomery County, Texas, under Clerk's File No. 2003068161, along with any supplements thereto or amendments thereof (the "Declaration"); and

WHEREAS, Article VI, Sections 1 and 11 of the Declaration authorizes the Association Board of Directors to promulgate rules and regulations applicable to all lots, units and common areas,; and

NOW THEREFORE BE IT RESOLVED that the Windsor Lakes HOA Board of Directors hereby adopts the following rules governing use of the lake in the common area associated with the Windsor Lodge property.

- Since the lake was installed primarily for esthetic purposes, for the enjoyment of all Windsor Lakes homeowners and guests, the following activities remain strictly prohibited: boating, all floating devices, wading and swimming.
- Activities that are permitted include: feeding the aquatic life in the lakes (turtles, fish, etc.)
 provided no trash is left in or around the lake and there is no decrease in the enjoyment of
 the lake from the vantage point of the sidewalk systems, including the pedestrian bridges
 and bench areas; and "catch and release" fishing, with restrictions.
- The restrictions on "catch and release" fishing are: fishing is restricted to Windsor Lakes
 residents and guests; fishing is allowed only during daylight hours; fishing only from the
 lake's banks and not from the bridges; casting is not allowed near the fountains; no net
 fishing.
- The Board of Directors may choose to modify the rules for governing lake usage at any time.
