WHEREAS, the Declaration of Covenants, Conditions and Restrictions for Windsor Lakes Homeowners Association, Inc.(Declaration), is filed in the Real Property Records of Montgomery County, Texas, under Clerk's File No. 2003068161, along with any supplements thereto or amendments thereof (the "Declaration"); and

**WHEREAS**, Article III, section 6(i) and Article X, Sections 9 and 10 of the Declaration authorizes the Association Board of Directors to promulgate restrictions, rules and regulations applicable to the Clubhouse, including the right to adopt rules and regulations governing the operation, management and use of the Clubhouse; and

WHEREAS, Article III, C, section 18(c) and (f) of the Amended and Restated By-Laws of the Windsor Lakes Homeowners Association, Inc., affirms the power and duty of the Board of Directors to provide for the operation and care of the Clubhouse, and to promulgate restrictions, rules and regulations applicable to the Clubhouse; and

**NOW THEREFORE BE IT RESOLVED** that the Windsor Lakes HOA Board of Directors hereby adopts the following rules governing collection of fees at the Clubhouse.

- Because there are concerns about security and the safety of Staff and Community members
  at the Clubhouse, and considering that collection of fees and expenses at the Clubhouse has
  resulted in large amounts of cash stored at the Clubhouse, cash will no longer be accepted
  for payment of fees and expenses exceeding \$5.00.
- Payment for all fees and expenses paid at the Clubhouse which exceed \$5.00 shall be by check.
- The Board of Directors may choose to modify the rules for collection of fees pursuant to the DCCRs, as noted above.
